

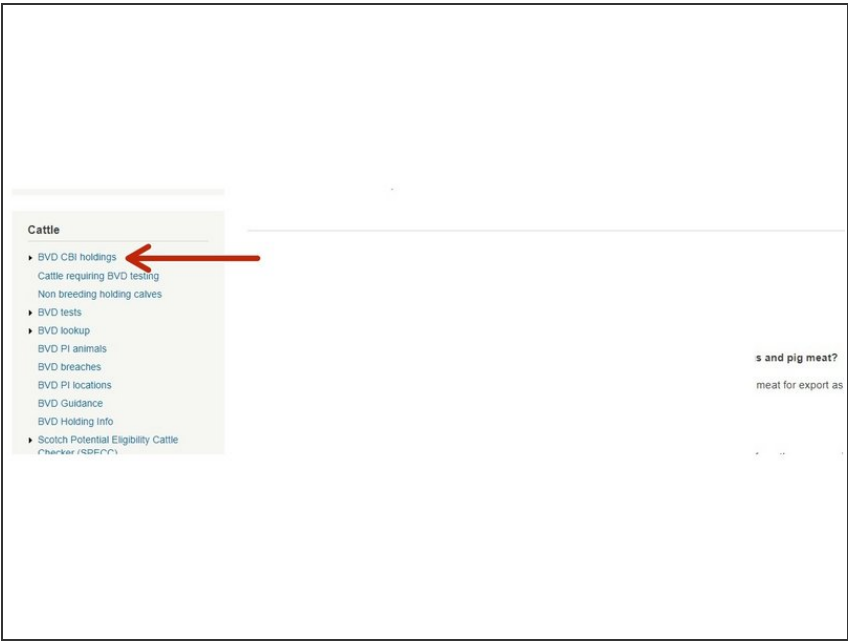

- Click on **BVD CBI Holdings** under the Cattle Menu down the left hand side of the ScotEID home page, as indicated by the red arrow.

Holdings appear on the CBI (Compulsory BVD Investigation) list when they have been continuously BVD not negative for 15 months. Keepers must comply with the requirements set out in the BVD (Scotland) Order 2019.

- Active status means the holding must start the CBI and complete it within 12 months of the start date. The keeper must make arrangements to get an individual BVD status for every animal on the holding.
- Complete status means the holding had an individual negative status for every animal on the holding, at which point the CBI completion certificate has been signed by the private vet. Holdings with complete status must test all calves born on the holding in the 12 months following CBI completion.
- Suspended status means the holding has been signed out of the CBI by the private vet. These holdings have BVD negative status. The trigger for the herd status renewal date reverts to the last herd status set by a BVD approved laboratory.

The presence of untested may animals in the herd for more than 40 days will change the herd status back to BVD not negative.

If the 'last clear date' column is empty it means that the holding has been BVD not negative since before 2016-05-30.

- Image one is an example of the CBI holdings table. You can sort by start date either in ascending or descending order by clicking on the icon, as shown by the black arrow.
- You can select how many records you view per page by clicking the arrows within the green box.
- Click on **Further information** as shown by the red arrow in the first image for explanations for the table headings. Explanations are shown in the second image.
- You can narrow your search criteria by clicking on the magnifying glass icon, as indicated by the blue arrow in the first image (the third image shows the search box). You can click on the paper icon next to this, as shown by the purple arrow, to download the information in the table.
- To narrow your search, click in the boxes shown by the red arrows in the third image. You can search by CPH, Status, All Risky, last clear, start date, end date. Click **Find**, as shown by the black arrow. To reset your search criteria, click on the icon as shown by the blue arrow.
